NEW CE REQUIREMENTS FOR 2010 AND BEYOND

The Louisiana Department of Insurance now requires individuals to renew licenses based on their birth month. Life, Health & Accident licenses with birth months through April 2010 are currently in line to renew. Beginning in May 2010, Property/Casualty licensees must begin renewals.

The Department will notify each producer in advance of the impending expiration of their license and will issue a similar notice with details regarding the renewal of property & casualty licenses as the time for those renewals draws closer.
